The international event is one of the most important for Public Prosecutors in Latin America! It will be a unique opportunity for Prosecutors and Attorneys from Brazil to exchange experiences with members of Public Prosecution Services from several other countries.

The event aims to strengthen international institutional ties, as well as to disseminate successful projects and experiences in matters of common interest, especially the work of the Public Prosecution Service in the guarantee of human rights and the Rule of Law. It will be a moment to highlight the performance of the Public Prosecutor's Office and its role in the protection of Democracy and Legal Security, as well as prosecution of crimes.

PRESENTATION AND SUMMARY OF THE CONFERENCE PROGRAM

The theme of the IAP Regional Conference to be held in Fortaleza – CE – Brazil on **June 28th to 30th, 2023**, has been determined as “Perspectives and Challenges to Prosecution Services”.

The main purposes of the Conference are to stimulate the exchange of experiences between prosecutors as well as to promote a comparative evaluation of national legal systems in strategic and important fields.

Taking as reference the main theme, the panels will address the following subjects: I) Independence and Autonomy of Prosecution Services; II) Fight against Organized Crime; III) Protection of the Environment; IV) Corruption and Money Laundering; V) Exchange and Cooperation Programs between prosecutorial training centers; VI) Digital Transformation of Prosecution Services; VII) Guarantees of Independence and Protection of Prosecutors; VIII) Data Protection in Prosecutorial Activities; IX) Combating Drug Trafficking and Urban Violence; and X) Protection of Human Rights.

The attendance is limited to 550 participants in a first-come-first-served registration process.

Registrations will be opening on February 6th. Early bird registration fee will cost R\$ 730 until May 31. After that, registration fee will cost R\$ 885.
